1. Introduction

The Muscat College (MC) mission is to provide quality higher education in management and information technology in Oman within a culture of creativity and innovation. The main purpose of this document is to substantiate with evidences, the obligations on staff and students who undertake research activity. The report is covering all the departments engaged in research activity, embodied in different disciplines. It primarily has work done by academic staff, including undergraduate and postgraduate students engaged in projects.

1.1 Purpose

The purpose of this report is to provide an annual report on all research activities, development and management at MC. It also reflects the improvements done in the research environment of the college for the academic staff and students who carry out their research.

1.2 Research Policy Principles

Policy on Research in MC encapsulates the following core principles:

- To ensure that a wide range of research is conducted in all disciplines.
- To improve the capacity of researchers and to develop the research capability of MC.
- To promote respect for research ethics, protection of research achievements and dissemination of research results.
- Develop effective procedures for grant and contract management.
- Facilitate efforts by staff and students to attract external funds in support of research.
- Ensure effective documentation and tracking of funding opportunities through the College, research council (TRC) grants, government organizations and local industries designed to
- Promote research in the institution.
- To encourage the utilization of research results for producing new knowledge and developments.



2. Research Unit Performance Criterion

The performance of the research unit is prepared and measured against the criteria specified by OAAA. It is prudent for the unit to present the performance as per these criteria to facilitate alignment with quality standards and maintain uniformity over various period reports.

There are eight criterions relevant to the unit, which are discussed in detail in following sub-sections.

2.1 Research Planning & Management

There was couple of areas under these criteria where good progress was made in the year 2016-17.

Research Fund- during this year, the top management has allocated around 7,300 RO for research activities. This budget was utilized for providing funding to staff but it wasn't utilized to its fullest extent.

Research Policy- there research policy has gone through a number of stages and drafts which by now the research policy reached to its almost final shape with multiple iterations of improvements. The policy is now under modification and it will be circulated among Academic Steering Committee (ACSC) members for getting their final approval.

Research Strategic and Operation Plan- the Strategic and Operation Plan of the research unit was prepared and approved in ACSC. This plan was aligned to the strategic plan of the Muscat College. The research goals were set according the college wide goals. The full achievement of the set goals could not be as per the plan for two reasons, (a) lack of research fund available internally and externally, and (b) faculty are spending more time in teaching and administrative duties than on research.

Risk Register- The research unit developed a risk register to identify various risks related to the research in the college with detailed description of its nature, impact, cost implications and the possible mitigation actions to be taken. The responsibility was also identified with persons/committees for taking appropriate actions. The implementation of the actions suggested in risk register was visible towards the end of the year, with more new staff being recruited and other actions being taken by the college



management. However, these were partially meeting the risks identified. Meeting all the risks involved more resources that were not feasible looking to bad economic situation.

2.2 Annual Research Performance

The research performance was acceptable giving the limited research support by the College in terms of fund and time allocation. There were number of research workshops and training programs organized for staff and students. The staff participated in conferences at national and international levels. There were publications made by staff in academic journals however most of these journals are not indexed by Scopus or Web of Science. There were some funded research projects also secured by staff and some of those successfully complete during the year. The detailed list is provided in the Appendix A.

The research work was supported through awarding paid leaves to staff and transferring their regular responsibilities to others. A total of 2 staff members earned their doctoral degrees from Business & Accounting and Computing departments with such support. Other research activities in terms of participation in conferences and workshops were are outlined in more details below.

2.3 Research Funding Schemes

The research funding was largely through the research unit and the external agencies such as the Research Council of Oman (TRC). The college provided indirect support through allowing paid leaves for research under different areas. The TRC funding scheme helped staff and students do some research projects with benefits to their knowledge and overall society. Some of the funding schemes (FURAP) available from TRC (The Research Council) were used by the students in college for their research under supervision and guidance of faculty members. There were two projects working with grants and both were successful completion. The details are there in Appendix A. There is one research projects approval from TRC this year.

2.4 Ethics and Biosafety

The nature of research in Muscat College does not involve experiments with chemicals or other hazardous equipments or elements that can pose danger to humans or



environment. All of the researches done in the college involved humans responding to questionnaires posed by the researcher or developing some program or algorithm for technology devices. Hence ethical and bio-safety concerns were not there. There was no research involving hazardous or bio-chemical waste carried out by the college staff. There were no experiments conducted involving living beings. The ethics part involving information sought and privacy of data was ensured through getting ethics form signed by the researchers. This form was applicable for students and staff and was used in all research.

2.5 Intellectual Property (IP)

The college has produced a section on IP rights during the year. All details are included in the research policy and appropriately linked to the IP laws of Oman and confirming to the international laws.

2.6 Professional Development for Research

There was limited research workshops organised for students to provide them theoretical and practical inputs on carrying out good quality research. This area needs further improvement and development in the coming year. Students are only engaging in research skills at the last year of their study.

The staff development workshops were also conducted. The staffs were oriented about how to do the research in a professional manner. 4 workshops conducted in the Business and Accounting department and targeted to all employees in the college.

The professional development through participation in research conferences and seminars was also encouraged by the unit. In the year the information and details of number of awards, conferences information was shared and promoted with staff and students in the college. The head of the unit provided the salient features of these research activities in simplified language because staff many time don't have time to go through all details running into 2-3 pages. The coordination with organising agencies was also facilitated wherever there was interest shown by staff/students.



2.7 Research Commercialisation

There was no research that reached to commercialization stage in year 2016-17. If in future some research reach to that level, the research policy has guidelines for the same.

2.8 Research - Teaching nexus

The objective of Muscat College is to promote research that benefits its students also. In order to achieve this objective it is ensured that research carried out in the college is linked to the teaching. In the year under review, initial steps were taken in this direction by the research unit through collecting evidences of the research conducted by staff and classifying according to research areas. The research output is linked to the teaching by some staff through class discussions and case studies with students. However, more work is needed to ensure that the implementation and documentation of these criteria is effectively done.

3. Conclusion

The research unit made some progress during the year 2016-17. From almost scratch, it started functioning and created policies and procedures for major research activities. The accomplishments become more noteworthy looking to the fact that the unit has single staff and that is Head of Research Unit. The role is required to do teaching of minimum of 10 hours besides other administrative works. However, there is much more to be achieved in research terms in order to meet strategic goals of the college. The summary of the year is presented in three headings below,

3.1 Major accomplishments of the year 2016/17

- The Research Unit created proper structure for its functioning by getting members from departments, after approval from ACSC.
- The research policy was finalized after detailed discussions at ACSC and CQAC.
 However there are some minor changes suggested that will be incorporated for approval.
- Two TRC funded research projects were approved by TRC and progress is happening on those.
- An operational plan was prepared for boosting the research activities in the college and sent for finance approval.



 Some awareness was created about research activities through regular communication on various opportunities to present/publish research papers among staff of the college.

3.2 Major challenges faced during the year 2016/17

- The biggest challenge was the lack of research outcomes due to the increase level of administrative works and teaching hours.
- The other challenge is in terms of support for creating documents needed for operations and quality purposes. The head of research unit has to manage all the reports and policies along with teaching.

3.3 Major upcoming projects /tasks for next year 2016/17

- Implement research training for staffs and students that match their research needs.
- Encouraging more staff research publications for ISI ranked journals.
- Encouraging students and staff to present research papers in national and international conferences.
- Organize national or international conference
